Financial Aid/Work Grant Program

Archbishop Mitty High School seeks to prepare its students for college and for responsible leadership in the global society of the 21st century. At the same time, the school works diligently with parents to foster the development of each student.

Archbishop Mitty recognizes that some students require financial support to pursue a Catholic, college preparatory education. It is a goal of the school Administration and the Board of Regents to give all qualified students, regardless of financial resources, an opportunity to attend AMHS. Two financial aid programs are available for Archbishop Mitty students: the Archbishop Mitty Work Grant Program and the Diocese of San Jose Scholarship Program.

The Work Grant Program requires each student to give service to the school in order to receive financial aid. Students are considered eligible for the Work Grant Program purely on the basis of demonstrated financial need.

The Diocese of San Jose Scholarship Program offers financial aid to students who are Catholic parishioners in the Diocese of San Jose. The Diocesan Scholarship Program is also awarded based on financial need and is only available to students who are also accepted into the AMHS Work Grant Program.

To apply for these financial programs, applicants must submit a Private School Aid Service (PSAS) Application to the AMHS Business office by February 4, 2008. Those applicants applying for the Diocese of San Jose Scholarship Program must obtain their pastor signature in Section M of the PSAS form. Application for tuition assistance through the Archbishop Mitty Work Grant Program and/or Diocesan Scholarship Program will in no way influence the selection process for acceptance to Archbishop Mitty. Enclose signed copies of all pages of your 2007 Federal Income Tax Return. **(If you have not yet filed or will not file a federal income tax return for 2007, enclose copies of your 2006 federal tax return along with your 2007 W2's. (Please see instructions in the PSAS application form (M) for the documentation required.)**

- Enclose all copies of 2007 W2 forms. (Required)
- Enclose signed copies of your 2007 Federal Income Tax Return (2006 Return if you have not filed for 2007)
- Enclose your check or money order, for \$20, payable to Private School Aid Service.
- List all schools and their codes to which your family is applying for financial aid (Section C.) If you are applying to more than one school in the Diocese of San Jose, you only need to complete one PSAS form.
- The amount of tuition that you feel you can pay must be filled out in section C. This should be the total amount your family can pay for the entire year.
- Section F must be filled out completely, including the estimate for 2008.
- If you have checked any box in section J, complete section L.**
- Sign and date the enclosed application.
- Return PSAS application to AMHS Business Office by February 4, 2008
